FAMILY PET VISITS



Can I bring Fido to my scheduled visit with mom /dad?

Yes, Pet visitors are welcome!

PET VISIT POLICY

- A copy of the animal's current vaccination, including rabies, must be supplied to the facility at the **FIRST** visit. Only animals with current vaccinations are permitted on campus.
- Family members may bring one pet to their scheduled visit with their loved one.
- Pets may **ONLY** visit with their resident. **NO** animal contact with other residents is permitted (no petting/touching).
- Pets must be **ON A LEASH** and under control **AT ALL TIMES**, inside or outside the facility.
- Pets must remain in the designated visitation area during the visit. Do not wander the campus or inside the facility.
- Pet owners are responsible for cleaning up after their pet (inside/outside) and disposing of pet waste in the appropriate containers.
- If you fail to comply with the policy you will be asked to remove your pet from the campus.
